

GARAGE COMPLEX IS UNDERWAY!

In June, the District broke ground on the new 10,000 SF garage workshop and office space. This new facility will house a workshop with ample area for electrical and equipment repairs. The crews will be able to perform technical programming and testing of field equipment. The facility will garage nearly all of the district's vehicles and equipment which are currently parked outdoors. Construction crews will be hard at work for the next four months as project completion is slated for November 30, 2015. The collection/pumping crew is looking forward to their move into this facility.



UPCOMING DISTRICT REFERENDUM - NOVEMBER 2015

In the previous edition we reported that the Town Council had authorized, and the Maine legislature had passed, an amendment to our Charter to increase the District's debt limit from \$20 million to \$25 million. The purpose for the increase is to fund the estimated \$22 million upgrade to the wastewater treatment facility. The new amendment does not become effective until the voters within the District approve the new debt limit in a referendum. We are working with the Town to include this referendum vote in the November 2015 election cycle. In that effort it is important for us to note a couple of items.

First, per our Charter, "All registered voters of the Town of Brunswick who reside within the District are voters of the District, for all purposes. In determining whether a voter resides within the District, if any part of his residential property lies within the District, he shall be considered to reside within the District." Even if your property is NOT connected to the public sewer system, if you reside within the District, you can vote on our referendum question and will be provided a ballot when you go to the polls in November.

Second, again per our Charter, "Bonds, notes, or other evidences of indebtedness issued under this Charter do not constitute a debt or liability of the state or the Town of Brunswick." The District, as a state chartered entity, is solely responsible for its debts -- not the taxpayers or the Town.

We ask both our rate payers and non-rate payers that reside within the District, for your continuing support of our mission, and encourage you to vote your approval in the upcoming November election. Thank you.

PUMP STATION UPGRADE

The Brunswick Sewer District's River Road #2 Pump Station located just beyond Patricia Road will be receiving a much needed upgrade at the end of the summer. Built in 1976 this pump station has seen a lot of growth and has put in some long hard pumping hours over the past 39 years. It serves On the Green Apartments to Fox Run Condominiums, and all in between, gathering the waste water before being pumped to the Treatment Plant. The new station will double the waste water capacity using larger pumps to handle the additional flows that the old ones were never designed for. In turn, the newer technology and capacity will allow for growth as well as better control of the pumping process. This will dramatically save in daily operation costs. Construction of this project is set to begin in late August.
