# OUTSIDE WATERING ADJUSTMENT POLICY

Draft Sub-Meter Program and Survey

The Sewer District is in the process of reviewing its outside watering bill adjustment policy. We are considering converting to a sub-meter program. Under this program, the only adjustment to the sewer bill, for water that does not enter the sanitary sewer system, will be based on a sub-meter reading. All water the sub-meter registers will be deducted from your sewer bill. As such, those desiring an adjustment for outdoor water use will need to install a sub-meter. Purchase and installation of a sub-meter would be at the rate payer's expense.

The review is still in the early stages and the District's Board of Trustees is asking for ratepayers' comments and thoughts regarding this new program. To that goal, a DRAFT Sub-Meter Watering Adjustment Policy has been posted on our website (www.brunswicksewer.org). Please send written comments to us at 10 Pine Tree Road, Brunswick, Maine. ### 2017 CAPITAL IMPROVEMENTS

Every year the District budgets improvements to its infrastructure. Maintaining the sewer lines, pump stations and treatment plant play an important role in the performance of an efficient sewer system. For this calendar year, the District has budgeted for the following three projects:

- The District will be replacing 850 linear feet of sewer main on Union Street. This will be a joint project with Brunswick Topsham Water District. Cost: \$127,500.
- 305 linear feet of sewer main will be replaced on Coffin Street. This will be a joint project with Bowdoin College. Cost: \$52,000.
- An upgrade to River Road pump station #1. Cost: \$265,000.

#### REMINDER OF RATE CHANGE APRIL 01, 2017

On December 15th the District's Board of Trustees took the first of two required votes to implement a proposed new rate schedule. The notice of the January 19th public hearing, along with the proposed rate schedule, was mailed to each rate payer, placed on the District's website and published in the Times Record. The public hearing was held as advertised. On February 16th the Board of Trustees will take the second and final vote to implement the new rate schedule for all sewer use beginning April 01, 2017.

When you are using water for your lawn, gardens, pools, or ice rinks you may be eligible for an outside watering credit. **TO REQUEST AN ADJUSTMENT, YOU MUST CONTACT US PRIOR TO THE END OF EACH QUARTERLY BILLING PERIOD.** 

Since the quarterly billing periods vary with your location you may contact us to determine your specific billing schedule. Please call 729-0148 ext 110 or e-mail ddutton@brunswicksewer.org for more information. **PLEASE NOTE: Credits will no longer be given after the bill has been produced.** You may view the policy on our website or request a copy be mailed to you.
